- Should I wish to opt-out or cancel my participation in the Member Death Benefit Insurance Program, I will inform the Credit Union in writing of my decision;
- My understanding is that my participation in the Program will automatically stop should I cease to be a member of Member First Credit Union or if there are insufficient funds on my account to cover the annual cost of my premium;
- I understand that the insurer can opt to terminate the Program and cover at the end of each Program period;

I confirm that the information I have provided to Member First Credit Union is correct and I provide my consent to this information being shared with CUNA Mutual and its insurers, for the purposes of my membership of the Member Death Benefit Insurance Program.
